# The Mystery Motel Diamond Hunt

## Contest Guidelines and Rules

## Contest Guidelines

**The Premise:** By playing all three of the Mystery Motel's escape rooms, participants are eligible to complete a city wide scavenger hunt (the "**Diamond Hunt**"). Participants who complete the Hunt successfully are entered into a draw as a team (between 2-6 team members), to win a prize package valued at over \$500. In 2018, there will be three draws. Each draw will occur after the window of eligibility closes for that respective draw.

**The Submission:** Upon successful completion of the Hunt, team members must submit their names and contact information to qualify for the team prize draw. Participants that complete the Hunt as a team must submit their names and contact details as a team and will only be entitled to share one ballot in the next draw. On the specified draw date, team ballots will be drawn and a single winning team will be selected.

**The Payout:** Each draw will feature prizing of approximately \$500 in value

**Submission Deadlines for each draw will be announced via Facebook and email as they approach.**

### **Other Key Information:**

- To be eligible to enter a draw and win a prize, each member of the team must have played all three rooms at the Mystery Motel. To book an escape room at the Mystery Motel, visit [www.mysterymotel.ca](http://www.mysterymotel.ca)
- If you complete all three escape rooms and have not signed up for the prize draw, you are eligible to sign up at any time prior to the deadline of the final draw.
- If you entered a submission for a draw and did not win, you cannot enter any subsequent draw unless and until you have re-played all three Mystery Motel escape rooms.

## Contest Rules

**Contest:** The Mystery Motel Diamond Hunt (the “**Contest**”)

**Contest Period:** February 22, 2018 to December 31, 2018 at 11:59pm (the “**Contest Period**”)

**Contest Sponsor:** Mystery Motel Inc. (“**MMI**”)

### 1. HOW TO ENTER

**Play all three escape rooms at the Mystery Motel and complete the Diamond Hunt.** To enter the Contest, complete all three rooms at the Mystery Motel and the subsequent scavenger hunt (the “**Diamond Hunt**”) to be eligible for the prize draw. For a team submission to be valid, all members of the team must have played all three rooms at the Mystery Motel and completed the Diamond Hunt.

### 2. ELIGIBILITY

The Contest is open to all Canadian residents. Each team must have one team member who has reached the age of majority in their province or territory of residence.

### 3. PROCEDURE FOR AWARDING PRIZING

During the Contest Period, the MMI team will select three (3) winning teams, one per each draw, using a random prize draw in each case (the “**Winners**” or a “**Winning Team**”). Each Winning Team will be notified by phone or email of their win and invited to a prizing ceremony (“**Prize Event**”) to claim their prize in person at 41 York Street, 3<sup>rd</sup> floor.

### 4. DESCRIPTION OF PRIZE

Each Winning Team will be awarded a prize package valued at approximately \$500.00.

### 5. GENERAL RULES

5.1. The Winners shall sign a release: declaring their eligibility as stipulated in Section 2 of these Rules; agreeing that their name, image and/or voice may be used for advertising purposes related to this Contest free of charge; and releasing MMI, and its directors, officers and employees (the “**Contest Parties**”) from all liability for any damage or loss arising from participation in this Contest or from the awarding, acceptance or use of any prizing.

5.2. Refusal to accept the prize releases the Contest Parties from any obligation toward any Winner.

5.3. The Contest Parties assume no liability for any loss, damage or injury (including death) to any person participating in the Contest, including without limitation the Diamond Hunt), or for any: (i) lost, stolen, delayed, damaged, misdirected, late, destroyed, illegible or incomplete entries; (ii) loss, theft or damage to software or computer or telephone data, including any breach of privacy; (iii) inability of any person to participate in the Contest for any reason including mistaken addresses on mail or e-mail; technical, computer or telephone malfunctions or other problems with computer on-line systems, servers, access providers, computer equipment, or software; congestion on the internet or at any website, or any combination of the foregoing; or (iv) damage to any person’s computer, including as a result of playing or downloading any material relating to the Contest. The Contest Parties are not responsible for any errors or omissions in any printing or advertising related to this Contest.

5.4. Contestants found or suspected of tampering with or abusing any aspect of this Contest, including, but not limited to, acting in violation of these Contest Rules or acting with the intent to disrupt the normal operation of this Contest, as determined by MMI, will be disqualified. Without limiting the foregoing, if any person submits multiple Contest submissions or, in an effort to submit multiple submissions, divides their team up so as to enter multiple Contest submissions, such individuals and their respective teams shall be disqualified from the Contest.

5.5. Each contestant’s personal information, including name and contact information, will be collected

by MMI solely for the purposes of: (1) administering and marketing the Contest; and (2) notifying the contestant of special offers and providing promotional materials regarding the products and services of MMI and shall not be used for any other purpose without express consent. By providing this information, you consent to it being used for the stated purposes.

5.6. Odds of winning depend on the number of eligible entries. All entries that are incomplete, illegible, damaged, irregular or that have been submitted in contravention of the Contest Rules and the Contest Guidelines may be disqualified by MMI.

5.7. MMI reserves the right to amend the Contest Rules or to terminate the Contest at any time without any liability to any contestant. Any amendments to these Contest Rules will be posted on the MMI website.
